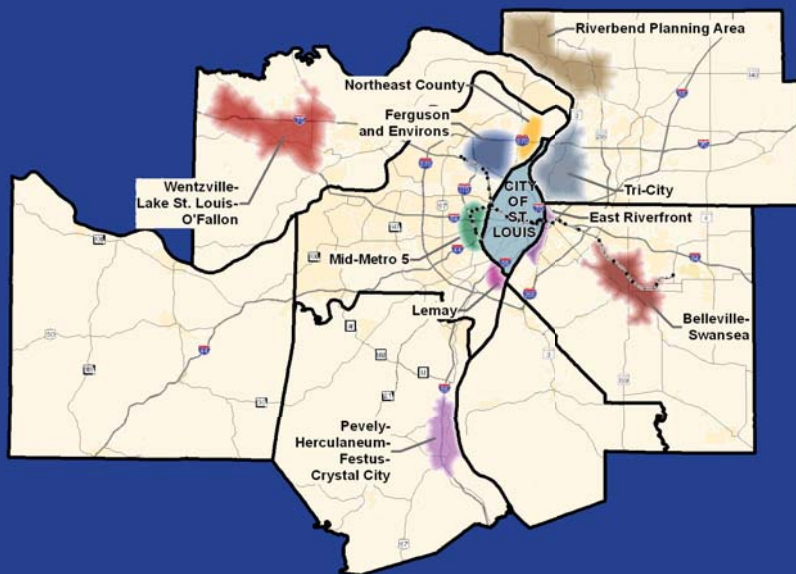


# Community Meetings
